

4-4-2 Picks hosted by Homestand Sports– Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE OR OTHERWISE IMPACT YOUR CHANCES OF WINNING. OPEN ONLY TO ELIGIBLE PERSONS WHO ARE: (A) LEGAL RESIDENTS OF CANADA (EXCLUDING QUEBEC); AND (B) AT LEAST NINETEEN (19) YEARS OLD AT THE TIME OF ENTRY. VOID IN ALL OTHER JURISDICTIONS WHERE PROHIBITED OR RESTRICTED BY LAW.

1. Promotion Period

4-4-2 Picks (the "**Promotion**") is a competition based on results of the 2023 English Premier League taking place from August 12, 2023 to May 19, 2024 (the "**Tournament**"). Entrants agree to abide by and be bound by all decisions of Northstar Bets or Homestand Sports (consumer division of Parleh Media Group) (each a "**Sponsor**"), which shall be final and binding, without right of appeal, in all matters relating to this Promotion and the awarding of the prizes, including without limitation eligibility and/or disqualification of entries.

2. Eligibility

The Promotion is open to legal residents of Canada (excluding Quebec) who are 19 years of age or older at the time of entry.

Excluded from eligibility are the officers, directors, employees, agents and representatives of Sponsor, any Promotion judges, and each of their respective parents, subsidiaries, affiliates, distributors, sales representatives, prize suppliers, advertising and promotion agencies (collectively, the "**Promotion Entities**"), and members of the immediate families (defined as parents, siblings, children and spouses, regardless of where they live) or households (whether or not related) of such officers, directors, employees, agents and representatives.

3. How to enter:

To be considered an entrant, visit 442picks.ca (the "**Promotion Website**"), complete an entry form with the required information such as your name and email address and follow the instructions for entry on the Promotion Website. Limit of one (1) entry form per person and email address. Mass entries, automated entries, duplicate entries, entries submitted by third parties will be void.

During the Tournament, 380 soccer matches will occur over 38 "Match Days". For the purposes of this Promotion, the Tournament is divided into ten (10) blocks (a "**Block**") each block will host approximately 3 or 4 Match Days (or 30 or 40 matches in total). The details of each Block are set out in the table below.

During each Block, entrants will be asked to correctly pick one of the following three (3) outcomes for up to ten (10) matches in each Match Day of the corresponding Block. All picks must be entered before the Match Day Cut Off time (as described in **Appendix A**):

- (1) Home win (4 pts)
- (2) Away win (7 pts)
- (3) Draw (8 pts)

For each correct outcome, each entrant will receive the assigned number of points as indicated above.

In the event that selected matches are rescheduled and not played during the Block, entrants will be given additional picks in the subsequent Block for each rescheduled match. For entrants with more than ten (10) picks in a Block due to rescheduling, only the ten (10) best scores will count toward their Block total. In the event of a tie, tie breaker rules will be used as further described in Section 4 below.

Further, entrants will be asked to enter their estimate of total number of goals to be scored for all matches occurring during a Block. This estimate will serve as a tie breaker.

4. Prizes, Prize Conditions and Tie Breakers

In order to be declared an official winner of any prize, the selected entrant must meet the conditions set out in Section 5 before the entrant is awarded the prize.

Monthly Prizes: Ten (10) monthly prizes are available to be won for each Block. At the end of each Block, the entrant with the highest number of points will be eligible to receive one (1) \$50 gift card. Further, the entrants in 2nd to 10th place based on their total number of points will each be eligible to receive a \$25 gift card. In the event of a tie, tie breaker rules will determine the potential winner.

May 2024 Prizes: For the May block month (Matchdays 36-38, inclusive) Ten (10) prizes are available to be won for the Block month. At the end of the May Block, the entrant with the highest number of points will be eligible to receive one (1) \$100 gift card. Further, the entrants in 2nd to 10th place based on their total number of points will each be eligible to receive a \$50 gift card. In the event of a tie, tie breaker rules will determine the potential winner.

Full Season Prizes: At the end of the Tournament, the following prizes will be awarded to each entrant according to their total number of points. In the event of a tie, tie breaker rules will determine the potential winner:

Leaderboard Full Season - 1 st Place Entrant	\$1,000 Cash
Leaderboard Full Season - 2 nd Place Entrant	\$500 Cash
Leaderboard Full Season - 3 rd Place Entrant	\$250 Cash
Leaderboard Full Season – 4 th to 10 th Place Entrants (a total of 6 entrants)	\$50 Cash each

Perfect Match Day Prize: \$500 (in the form of a cheque) will be awarded to each entrant who makes 10 correct picks for any given Match Day during the Tournament. For the May block month (Matchdays 36-38, inclusive), the prize will be \$1,000 (in the form of a cheque). For the purposes of the Perfect Match Day prize, all matches must be played on the date and time appearing on the English Premier League Schedule dated July 21, 2023. In other words, games rescheduled for later in the season, for which the entrant received compensatory picks, are not valid picks. In the event more than one (1) entrant has 10 correct picks on any given Match Day, tie breaker rules will determine the potential winner.

Grand Prizes: \$250,000 (in the form of a cheque) will be awarded to each entrant who makes all correct picks in a Block. For the purposes of the Grand Prize, all games picked must finish prior to the end of the last scheduled game in each Block. In other words, games rescheduled for later in the season, for which the entrant received compensatory picks, are not valid picks. In the event more than one (1) entrant has all correct picks in a Block, tie breaker rules will determine the potential winner.

Tie Breaker Rules:

1. Most correct draws picked
2. Most correct away teams picked
3. Most correct home teams picked
4. Closest total score guess

In the event there are still ties after the tiebreaker, the prize will be shared.

Prize Conditions: For purposes of the Grand Prize and Perfect Match Day prize, if no entrant is successful in meeting the prize criteria, the Sponsor is under no obligation to award the prize.

Prize amounts are in Canadian dollars. All prizes must be accepted as awarded and may not be substituted, transferred or redeemed for cash (as applicable) or otherwise, except at Sponsor's sole discretion. Certain prizes are subject to supplier's terms and conditions. Sponsor reserves the right, at its sole discretion, to substitute a prize of greater or equivalent monetary value if a prize cannot be awarded as described for any reason. Prizes will be delivered to verified winners only to one (1) address in Canada. Sponsor will not replace any lost or stolen prizes. Any other costs or expenses associated with the prizes not specified herein will be the responsibility of selected winners.

5. Odds, Notification and Prize Claim Conditions

Odds of winning depend on the number of eligible entrants and/or their picks based on the outcome of each match.

Potential winners will be notified by phone and/or by email at the end of each Block or at another time during the Promotion given the nature of the prize, all as determined by Sponsor.

In order to be declared an official winner, selected entrant(s) must: (i) respond to notification within five (5) calendar days of first notification attempt (ii) correctly answer a time-limited mathematical skill-testing question to be administered by Sponsor; (iii) if requested by Sponsor, sign and return to Sponsor within ten (10) business days of issuance a written declaration and release form, releasing the Sponsor and Promotion Entities from any liability in connection with this Promotion or the use, misuse, awarding or possession of any prize (the "**Release**"); and, (iv) otherwise comply with these Official Rules.

Failure to provide proof of eligibility (if requested), release documents, or other required documentation in a timely manner, failure to correctly answer the skill-testing question, or other non-compliance with these Official Rules may result in disqualification, forfeiture of the prize and, at Sponsor's sole discretion, selection of an alternate eligible entrant for the forfeited prize in accordance with these Official Rules, who will be subject to disqualification in the same manner.

6. Right to Void / Terminate / Suspend / Modify

Sponsor reserves the right to terminate, suspend or modify this Promotion, in whole or in part, at any time and without notice or obligation if, in Sponsor's sole discretion, any factor interferes with its proper conduct as contemplated by these Official Rules. Without limiting the generality of the foregoing, if the Promotion, or any part thereof, is not capable of running as planned for any reason, including but not limited to infection by computer virus, bugs, tampering, unauthorized intervention, fraud, programming errors, or technical failures, which, in the sole discretion of Sponsor, corrupt or affect the administration, security, fairness, integrity or proper conduct of this Promotion, Sponsor may, in its sole discretion, void any suspect entries and: (a) terminate the Promotion, or any portion thereof; (b) modify or suspend the Promotion, or any portion thereof, to address the impairment and then resume the Promotion, or relevant portion, in a manner that best

conforms to the spirit of these Official Rules; and/or (c) award the prizes from among the eligible, non-suspect entries received up to the time of the impairment in accordance with the winner selection criteria discussed above.

Sponsor reserves the right at its sole discretion to disqualify any individual who tampers or attempts to tamper with the entry process, the operation of the Promotion, violates the Official Rules, or acts with intent to annoy, abuse, threaten or harass any other person.

In the event that the Promotion is challenged by any legal or regulatory authority, Sponsor reserves the right to discontinue or modify the Promotion, or to disqualify Participants residing in the affected geographic areas. In such event, NorthStar Bets shall have no liability to any Participants who are disqualified due to such an action.

7. Limitation of Liability and Releases

Homestand Sports and its authorized agents will collect, use, and disclose your personal information for the purposes of administering the Promotion and prize fulfillment. Your personal information will not otherwise be used by Sponsor except for the administration of this Promotion. Mass entries, automated entries, duplicate entries, entries submitted by third parties, and any entries or prize claims that are late, incomplete, fraudulent, illegible, unidentified or delayed will be void. All entries and prize claims are subject to verification. Proof of entry submission does not constitute proof of receipt.
